QUARTERLY ISSUES/PROGRAMS LISTS

LATEST LIST DUE JANUARY 10, 2023

Under the Commission's Rules, commercial and non-commercial full-power AM, FM, and TV (and Class A low-power television) broadcast stations must place in their online public inspection files, every three months, a list of programs that have provided the station's most significant treatment of community issues during the preceding three-month period. The list for each calendar quarter is to be placed in the online public file by the tenth day of the succeeding calendar quarter (*e.g.*, January 10 for the preceding quarter October - December; April 10 for the preceding quarter January - March; July 10 for the preceding quarter April - June; and October 10 for the preceding quarter July - September).

These lists must be uploaded to your Online Public Inspection File that should already be established and operating. To upload the Filing, the File should be placed uploaded in "Manage Public Inspections Files" in the Tab entitled "Issues/Programs Lists."

This latest list should cover the period October 1, 2022 – December 31, 2022.

The list must include a brief narrative describing what issues were given significant treatment during the preceding quarter, and a list of illustrative programming that addressed those issues during that quarter. The description of the programs shall include, but shall not be limited to, the time, date, duration, and title of each illustrative program on which the issue was treated. Generally, a list of five or so local issues, and a listing of at least several programs that were broadcast with respect to each issue that addressed those issues, is considered adequate. The programming that is listed need not include only locally-produced programming – if appropriate (*i.e.*, if the programming addressed a local community issue), the list also can include non-local purchased, national, or syndicated programming that has been broadcast on your station.

The quarterly issues/programs list described above must be retained in each station's Online Public Inspection File until final action has been taken on the station's next license renewal application.

FCC fines for failing to place the lists in the station's public file on a timely basis are significant. Fines ranging from \$4,000.00 to \$10,000.00 are not unusual. Failure to timely place the list in your public file also can affect processing of your next application for renewal of your broadcast license.

A sample Chart that can be used to keep track of issue-responsive programming is attached hereto. Licensees should check to ensure that lists for all quarters since the grant of your last renewal application are also properly in the Public Inspection File. I also am attaching a Sample of a client's completed Issues/Programs list.

These lists have to be retained in the Online Public Inspection File for the entirety of the current license term.
